## **TECHNICAL SPECIFICATIONS**

#### **APPLICATION:**

This range of water meter is ued to measure the total quantity of cold potable water passing through the pipeline.

#### **FEATURES**:

Brass or Plastic meter body, Multi-jet, dry dial, with external regulating device; Low transmission resistance; Magnetic shield; Long term working life

## INSTALLATION STATEMENT

- 1. The nominal diameter of water meter should be selected according to the volume of water passing through the pipeline
- 2. Attention should be paid that cold water meter must not be used for hot water and caustic liquid
- 3. The water meter is recommended to be installed in a horizontal postion with the register face upwards



- 4. The location for the water meter installation should be protected from the affection of sunshine and frozen. The water meter should not be installed under the surface of water
- 5. The meter must be installed with the water flow direction same as the arrow indicated on the meter body (see following drawing)



- 6. In order to keep the water meter in good working condition, the pipeline should be clear up before installing the meter
- 7. Use the couplings, coupling nuts and gaskets to connect the water meter with the water pipe in both ends
- 8. The valves should be installed in front and back of the water meter
- 9. During the service time, keep the water meter lid closed. Keep the surface of the register clean to make clear reading during the long time service



## VERIFICATION PROCESS

Calibration:

(1) Place the water meters on the test bench, start water flow and wait until there is no air in the pipe. Then stop water flow.

(2) Read the initial index of tested water meters, make a flow rate (Q3/Q2/Q1) and when related water magnitude has been passed, stop water flow. Then reading final index of tested water meters. And calculate relative index error of tested water meters with following formula:

[(Vf-Vi)-Vr] / Vr Vi: Initial index of the water meter Vf: Final index of the water meter Vr: Real volume (measured by the reference device)

Note: with automatical test table, there is no need to read initial and final index

## CUSTOMER ATTENTIONS

- Damages and defects which take place during the loading , unloading and transport after the product is delivered to the consumer.
- In the event that there are alterations on the guarantee certificate ,the orginal serial number on the product is removed or altered.
- Damages and defects caused by use errors.
- Defects in the meters which are not protected by the negative effects of the external atmospheric conditions (mechanic impact, rain and dust, freezing, direct sunlight)
- Defects caused by the foreing objects in the installation
- Meters with removed seals are not covered by guarantee.

### MAINTENANCE

There is an obligation of maintenance and calibrations every six years at the repair and calibration stations authorized by the Ministry department. And the repaired and maintened water meter should be tested again according to the standard flow rate listed in the Main Technical Data before reinstalled.

## **GUARANTEE**

1. The guarantee will start from the delivery time to customers.

2. The water meters will be guaranteed for one year under the right use, and no intervention is made by third people other than the service staff authorized by AIMEI for maintenance, repair or another reason.

3. The fail water meter without no intervention by others, will be repaired free of charge in the guarantee period. And the time is added into the guarantee time, but maximum is 30 working days. The time will be recorded from the date of reporting to the sales of manufacturer.

4. The replacement will be provided with free of charge, if same problem occurs twice or separated problems occurs in guarantee year.

5. The defects caused by usage of the product not conforming to the points mentioned in the user manual are not covered by this guarantee.
